This tournament, our 62nd club tournament, will have events for all levels of play. The tournament will be held at the gymnasium of the Rutland Area Christian School in Rutland, Vermont. This school is located at the corner of Melrose Ave. and Lincoln Ave. in Rutland, a block from the intersection of Route 7 and Melrose Ave. (110 Lincoln Ave., Rutland, VT 05701).

Eligibility – Note – Important: Ratings Central ratings (and in some cases, USATT ratings) will be used. If you have a Ratings Central rating, it can be found by going to Ratings Central at www.ratingscentral.com (go to "Players", enter your name with a space after the comma - "Smith, Joe", enter your State and Sport – Table Tennis) or in some cases, if you haven't played in some time, you can contact Tournament Director Ronald Lewis (above). All USATT ratings can be found at www.usatt.org. All unrated players may enter any rated event for \$5 per event, but will not advance beyond the first round in rated events only, with the exception of Under 700 (Novice), and Open (Championship) Singles (full entry fees will be charged for these events).

Rules: USATT regulations apply. The GMTTC will implement the rules and group players in the best interests of the players and the tournament.

Equipment: All paddles and rubber must be USATT-approved. USATT-approved balls will be provided; both white 40+ 3-star Premium Nittaku and orange 40+ 3-star Nittaku (made in Japan, not China) balls will be used at this tournament! **Balls are being generously donated for this event by Paddle Palace**. Six Butterfly Europa Stationaries are being used at this tournament. Nets are cloth, standards are Butterfly Europa and Butterfly National League. We also have heavy-duty cardboard barriers to keep balls travelling to unwanted areas of play.

Dress: Sneakers are required (the gymnasium is a linoleum tile floor). Solid, dark-colored clothing is also required; light-colored shirts may be subject to default. **Please do not wear orange or white shirts. Check-in:** Please check in at the Director's table upon arrival and be ready to compete when called or be liable to default (or penalty). Events will not be delayed for late arrivals. **Please retain your sign-up schedule (top portion of application)**. If you find that you cannot participate, although you had already signed up, please call (802) 247-5913 the day before the tournament; phone calls to tournament site on the day of the event may be directed to (802) 779-4305 – the cell phone of Tournament Director Ron Lewis. **Entry Deadline:** All entries should be received by 11:00 pm Wednesday, December 4, 2019. Late entries and walk-ins may be unable to enter all events of their choice. Phone-in entries after Monday, December 2nd, may be unable to enter all events of their choice.

Format: All events will be <u>Round-Robin</u>. The top two winners of each group will be seeded into a <u>Single Elimination</u> format for the finals. All matches will be 3 out of 5, 11-point games, including finals. **Food:** Sandwiches and other items for lunch can always be purchased from nearby Rutland eateries. As a special convenience to both players, tournament directors and volunteers, we <u>may</u> be gathering sandwich orders around noon and thus be making a sandwich run to the nearby Sandwich Shoppe or Gill's.
